BILL

To amend the University of Durban-Westville Act, 1983, so as to substitute a definition; to further regulate the constitution of the council; and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 81 of 1983

1. Section 1 of the University of Durban-Westville Act, 1983 (hereinafter referred to as the principal Act), is hereby amended by the substitution for the definition of “Minister” of the following definition: 5
 “ ‘Minister’ means the Minister of [**Internal Affairs**] Education;”.

Amendment of section 8 of Act 81 of 1983, as amended by section 1 of Act 51 of 1993 and section 1 of Act 82 of 1996

2. Section 8 of the principal Act is hereby amended by the substitution for paragraph (f) of subsection (1) of the following paragraph: 10
 “(f) not more than two persons nominated by the Durban Metropolitan Council in consultation with the North Central, South Central and Inner West City Councils of the Durban Metropolitan Council;”.

Transitional provision 15

3. The members of the council of the University of Durban-Westville who served in the council by virtue of section 8(1)(f) of the University of Durban-Westville Act, 1983 (Act No. 81 of 1983), before the date of commencement of this Act, shall cease to be members of the council from the said date.

Short title and commencement 20

4. This Act shall be called the University of Durban-Westville (Private) Amendment Act, 1997, and shall come into operation on a date determined by the President by proclamation in the *Gazette*.

**MEMORANDUM ON THE OBJECTS OF THE UNIVERSITY OF
DURBAN-WESTVILLE (PRIVATE) AMENDMENT BILL, 1997**

1. The object of the University of Durban-Westville (Private) Amendment Bill, 1997, is to make provision for representation on the council of the University by members of the new local authority dispensation.
2. As part of the consultative process followed in framing the amendment, the relevant local authorities were briefed as to the content thereof.
3. In the view of the University and the State Law Advisers the procedure set out in section 75 of the Constitution should be followed with regard to this Bill.
